The Medallion* syringe contains a calibrated hollow barrel into which is inserted a closely fitted movable plunger and tip or O-Ring. The barrel contains a fixed male luer connector, which is compatible with female luer hubs.

INDICATIONS FOR USE

The Merit syringe is used to inject fluids into, or withdraw fluids from, the body.

INSTRUCTIONS FOR USE

- 1. Using aseptic technique, open the package containing the sterile product.
- 2. Inspect for damage or improper assembly.
- To prep the syringe, using one or two hands, pump the piston back and forth several times to ensure that the piston moves smoothly.
- 4. To withdraw fluids, pull the plunger back and maintain pressure.
- 5. Connect the syringe head to the female luer by turning the syringe clockwise.
- 6. To inject, push the syringe plunger, injecting the appropriate amount of fluid.
